Originating from that inspired vision two decades back, Lions Aravind Institute of Community Ophthalmology (LAICO) became a reality in 1992. LAICO, established with the support of the Lions Club International Sight First Programme and Seva Sight Programme, is Asia's first international training facility provider for blindness prevention workers from India and other parts of the world.

LAICO partners with the international NGOs Christoffel Blinden Mission (CBM), Sight Savers International, the Lions Sight First Programme, International Eye Foundation and the Seva Foundation in working with the participating eye hospitals. Currently, LAICO is working with 178 hospitals spread across India, South-East Asia and Africa. LAICO, through its various activities, contributes to eye care in India and developing countries of South East Asia and Africa. Its activities include:

To partner and collaborate with the Eye Hospital, to strengthen the eye care services through:


- Redefine the eye hospital's leadership's vision and goal so as to meet the community eye care needs as well as build their hospital's capacity through better management practices.
- Develop efficient and effective systems to do high volume, good quality cataract surgery at low cost
- > Develop strategies to become financially sustainable through patient revenues
- Identify the catalytic and critical inputs that will help the hospital to make changes leading greater effectiveness and efficiency
- Provide the staff of the Eye Hospitals necessary clinical and management training (against specific request and course fees)

Start-Up Eye Hospitals

Program Objectives:

To guide those who are setting out to build an eye hospital or who have started a hospital in its design, equipping and staffing, to reflect the eye care needs in the service area and organizational philosophy. This will be done in a manner so that the whole project lends itself to becoming a sustainable eye care project.

PHASES IN CONSULTANCY PROCESS





Consultancy is offered through the following phases:

Needs Assessment Visit:

LAICO teams conduct needs assessment visits to the hospitals to gain a better understanding of the working systems and management structure. They also establish a framework for capacity building specific to each hospital.

Vision Building, Strategy Planning, Manpower and Management Development Workshops:

The workshops provide an environment for the key personnel from each hospital team to evolve a vision for their hospital. The workshops also help them to develop various strategies by which this vision can be translated into reality. These strategies are then formed into detailed action plans relating to social marketing, service delivery, demand generation quality assurance and financial viability.

On-site consultancy during follow-up visits:

After allowing six months for the hospitals to implement their strategies, the LAICO - Aravind team makes follow-up visits to provide further support to the hospitals in implementing their action plan.

Monitoring through monthly reports and further follow-up visits:

All the hospitals send a monthly performance report to LAICO that records information to gauge the effect of the capacity building process and to plan for further support. Further follow-up visits are conducted as per the requirements of each project. As per the individual requirements of the partner hospitals, LAICO also conducts workshops in skills development and standardization of systems. The skills development workshop imparts skills in solving problems, managing change and communicating ideas. It then integrates the application of these ideas into the daily operation of the hospitals. The standardization workshop updates clinical and administrative procedures to be adopted by the partner hospitals. These procedures enhance the quality and effectiveness of the eye care services provided by the hospitals.
